Pursuit of Position FY 2022-2023

- Continue child care family fee waivers for all state subsidized early learning and care programs through June 30, 2024
- Increase current reimbursement rates for state subsidized early care and education programs by 25% and adopt an alternative methodology using a cost estimation model and include a timeline for implementation for the actual cost of care based on program enrollment without charging families fees

President Biden Executive Order

Make child care and long-term care more accessible and affordable for families by directing federal agencies to:

- Lower costs for families benefitting from the CCDBG program, including by directing the Dept. of Health and Human Services HHS to consider actions to reduce or eliminate families' co-payments for child care
- Ensure the federal government is a model employer by supporting its own workforce
- Provide support for our service members and their families by directing the Dept. of Defense to take steps to improve the affordability of child care on military installations

Membership Application for Parents/Primary Caregivers - 2023-24

The Child Care Planning Committee (Planning Committee), staffed by the Office for the Advancement of Early Care and Education located within the Los Angeles County Department of Public Health, is made up of parents/consumers who currently use early care and education services or have used it within the past 36 months for a child from birth to 12 years old (may be a biological parent, adoptive parent, legal guardian or other person serving as the child's primary caregiver, such as a relative or foster parent in absence of parent), early education providers (centers and family child care), public and community agencies, Board of Supervisor appointees, and other discretionary members.

The Planning Committee, through a contract with the California Department of Social Services, is responsible for identifying issues faced by families for finding early care and education services to inform planning and actions that better meet the needs of families throughout Los Angeles County. Your voice as a parent or primary caregiver is important to making sure that policies and programs are meeting your *child's* and family's needs. The Planning Committee meets at least five times a year in-person, on the first Wednesday of the month, to tackle issues relating to access, quality, workforce, and family and community engagement. Members are expected to attend five Planning Committee meetings and work groups as needed. See meeting dates on page two.

TK and UPK



Benefits of UPK

- Increased access for programs for 4 year olds
- Early education becomes an entitlement by embedding it in TK-12
- Free services without parent fees

Challenges of UPK

- Loss of ECE workforce to TK employment
- TK is not full day
- Impact on infant/toddler care
- LEA can not contract TK with mixed delivery system
- Families are charged fees

Allowable Costs for UPK Grants



Mixed Delivery Grant

- Lead-OAECE (Local Planning Council)
- Allowable Costs
 - Coordinate with LACOE
 - Form a single local Work Group
 - **Plan** for UPK in mixed delivery system
 - Plan for increasing inclusion of children with exceptional needs
 - Plan for workforce development
 - Provide outreach services and enrollment support
 - Partner with tribes

Understand what parent's need for their young child regarding early care and education Facilitate listening sessions and administer survey to understand what parent's need, create a report, and convene stakeholder to garner recommendations.

Inform parents' about their early education choices

Implement early education choice campaign, establish single website for early education choice information, employ community liaisons to partner with parents and share information about preschool choice.

Establish local partnerships between LEAs and ECE mixed delivery system

Establish contracts with community based ECE providers to provide TK, explore alternative funding models adopted by other states, establish emergency credential for ECE mixed delivery, explore expansion of Family Child Care Home Education Networks.

Create and implement a unified eligibility and enrollment system for all 3–4-year-olds Build a single data base to determine eligibility and enrollment for all 3–4-year-olds, train all referral mechanisms with common language and process, build the capacity of the referral points with family-friendly tools and staff.



Develop plan to improve collaboration and coordination of special needs services

Map special needs support services, establish LA County collaborative to support children with special needs, strengthen service coordination, support workforce through training and coaching.

Partner with Workforce Pathways to strengthen supports for early educators who serve 3 and 4-year-olds

Provide funding for substitutes when early educators attend trainings, provide early educators serving with financial incentives for 16 units of child development coursework.

Develop plan for recruitment and retention of diverse workforce serving 3- and 4-year-olds with focus on workforce equity

Convene credential and permit programs to ensure accessibility, identify training and coursework offered during non-traditional hours, explore how other states have worked towards pay parity for early educators.

Develop a unified training plan for all early educators in UPK across LEAs, centers, FCC, and funding streams

Partner with QSLA to develop a unified training plan for early educators who serve 3- and 4year-olds, facilitate listening sessions, map a professional development.

- R&Rs provide educational options materials to 1,600 parents by 06/26.
- Develop shared goals for a joint LACOE /R&R website 06/25.



- Partner with QSLA to plan training for early childhood educators that serve 3- and 4year-olds in LEAs, non-LEA centers, and family child care homes


