Timeline

- Nominations May and June 2025
- Election June 2025 (Election takes place every 2 years and in June of the 2nd bi-annual year)

Who is Eligible to be an Officer (Chair and Vice-Chair)

- Each Roundtable member is eligible to serve as an officer
- An officer may be elected to additional consecutive terms; however, no officer shall be eligible to serve more than 2 consecutive terms

Nomination Process

- Vice-Chair recommends next Vice-Chair
- Candidates may be nominated:
 - Prior to the election meeting by:
 - 1. Emailing nominations to OAECE staff (Leanne Drogin)
 - 2. Providing verbal nomination during May 14, 2025 Policy Roundtable meeting
 - From the floor at the election meeting (June 11, 2025)

Election Process

- All Roundtable members are eligible to vote in the election of officers
- The election will be held by voice-vote at the election meeting, there shall be no secret ballots or absentee voting
- In order for an election to take place at lease two-thirds of voting members must cast a vote for election of officers
- The candidate that receives a majority of votes will be declared the winner

Status of Pursuit of Position #1: Alternative Reimbursement Rate Methodology

Establish by July 1, 2025 an alternative rate methodology that reimburses ECE providers the true cost of providing statesubsidized child care based on Federal requirements; implement the new reimbursement rate structure by summer 2025; and allocate ongoing funding for the new reimbursement rate structure.





Status of Pursuit of Position #2: California Safe Haven Schools and Child Care

Support AB 49 and similar measures that strengthen protections for immigrant children in California by prohibiting immigration enforcement officers from entering schools and child care facilities without proper legal authorization.

Presentation on **Family UPK Decision Making Survey** conducted by:



- Partnership: Stanford RAPID Survey Project
- **Surveyed:** CA families with a preschool-aged child (3-5) about their ECE decisions and experiences for 2023-24 school year
- Fielded: July 12, 2024 to August 9, 2024
- Sample:

California

2,408 respondents

Represents 1,068,445 households with children 3-5 years

LA County

718 respondents

Represents 238,263 households with children 3-5 years



What factors had the biggest impact on LA families' decisions?

- 1. Location was close to home
- 2. It was free
- 3. Qualified staff
- 4. Wanted child in same arrangement as sibling
- 5. Hours met their needs



Top reasons for not selecting TK in 2023-24, among LA families with a TK-eligible child

- 1. Wanted child in same arrangement as sibling
- 2. Wanted different learning environment
- 3. Child was not eligible for TK
- 4. Too far away
- 5. Not offered at elementary school
